5. Termination

- 5.1. **By Service Provider:** The Service Provider may terminate this agreement by giving written notice at least 30 days in advance. No refund shall be given for any termination without prior notice.
- 5.2. **By Connect Himal:** Connect Himal may suspend or terminate the listing without refund if the Service Provider violates policies, submits false content, or receives repeated customer complaints.

6. Miscellaneous

- 6.1. **Governing Law:** This agreement shall be governed by the laws of Nepal.
- 6.2. **Modifications:** Connect Himal reserves the right to modify this agreement. The Service Provider will be notified of any changes.
- 6.3. **Limitation of Liability:** Connect Himal acts as a service promotion platform and is not responsible for actual service delivery or outcomes.
